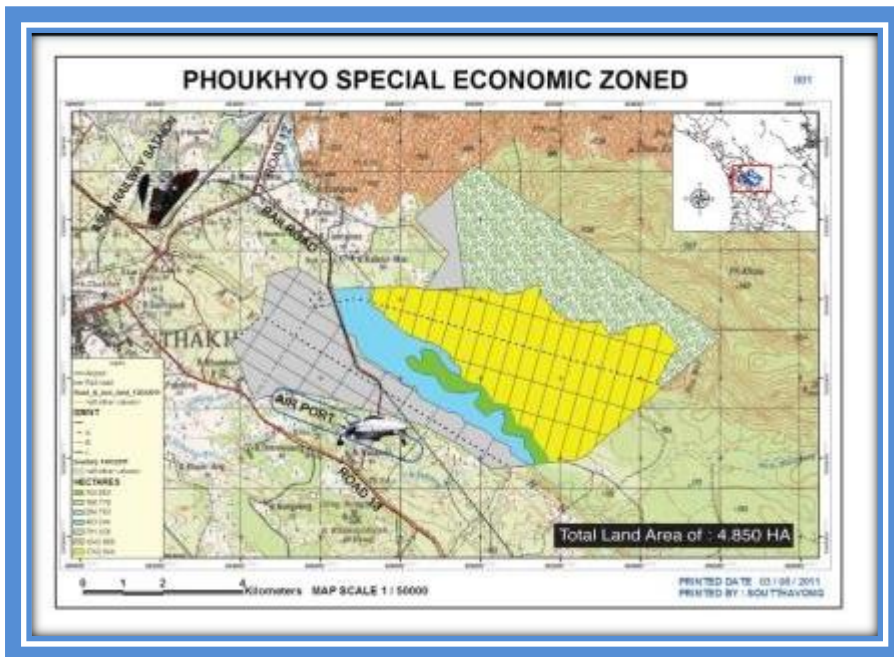
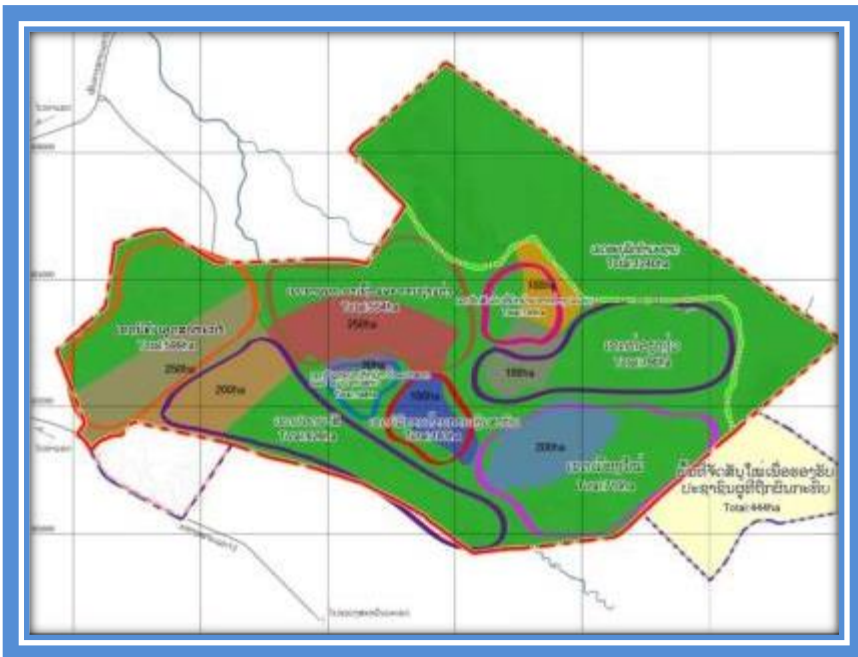

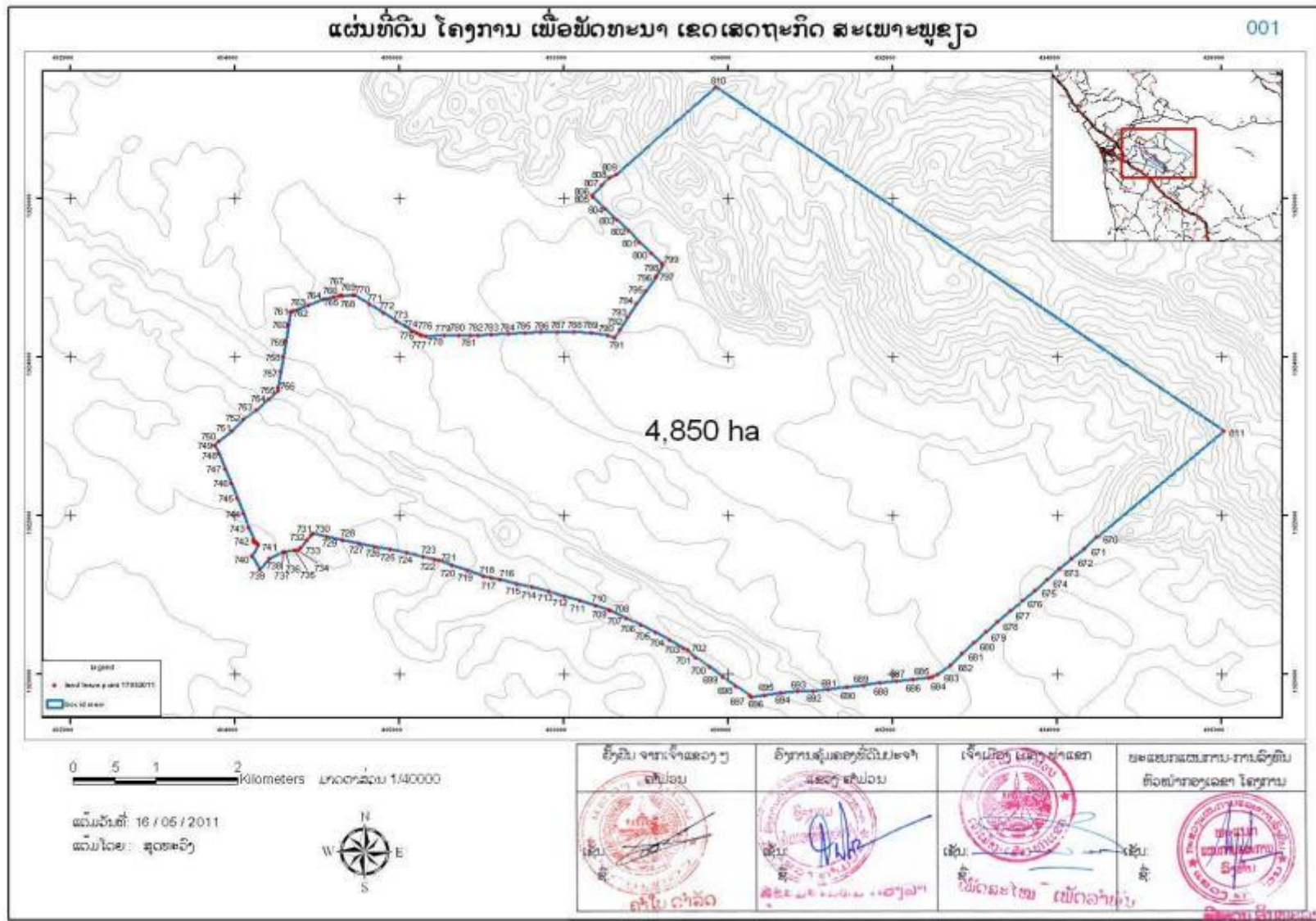
The concession area of 605 ha Concession Agreement Signing Ceremony in 2002



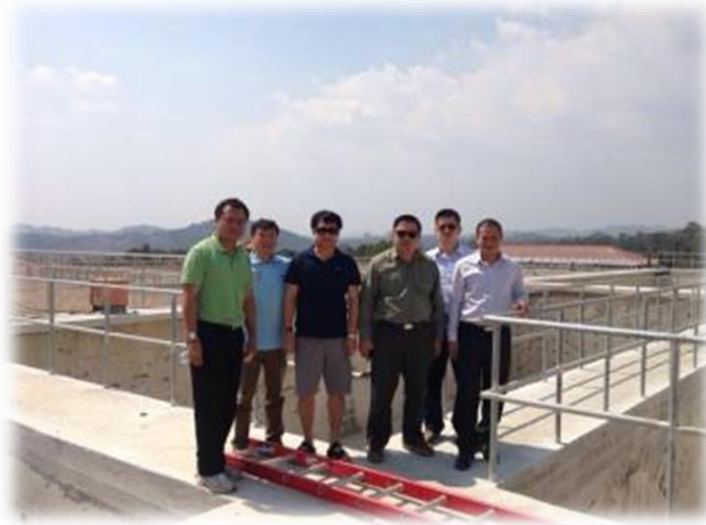
7.2 Phoukhyo Specific Economic Zone Development Project in Khammouan province with the land area of 4,850 ha:
